This multi-sector, not-for-profit society is committed to planning for an ecologically healthy watershed while ensuring environmental, economic and social sustainability.

The Mighty Peace Watershed Alliance is a group of active stakeholders a n d communities that use consensus decision-making, adaptive management, and innovation to understand and promote living within the watershed. The Board will report on the state of the watershed, lead watershed planning activities, promote best management practices and develop educational programs.



About the Mighty Peace Watershed Alliance


The MPWA is guided by its vision, mission, goals and shared values:

Message from the Executive Director

It is always amazing how quickly time passes, the Mighty Peace Watershed Alliance has just completed it's 7th year as an organization. Once again some major milestones were achieved: the completion of the first IWMP (Integrated Watershed Management Plan), working with Grimshaw Gravels Aquifer Management Advisory Association regarding a source water protection plan, restoration projects and numerous education and outreach events to name a few. The opportunities to engage and work with the stakeholders throughout the watershed are abundant and provide excellent partnerships for current and future work. The diversity of this watershed and its people have always been a treasure and a challenge when working in the area of watershed planning and management.

The Board continues to be committed to the goals of Alberta Government's 'Water For Life Strategy' – Safe, secure drinking water; Healthy aquatic ecosystems; Reliable, quality water supplies for a sustainable economy. The Directors are dedicated to the work of the organization therefore, spend a great deal of time and effort working, reviewing, learning, educating, reviewing policy, and planning. The work of the MPWA is to engage multiple sectors to plan for future water uses and needs, while protecting water quality and quantity. We would encourage all people of the watershed to think about how they live, work, and play, and see if there are improvements that can be made that will benefit our watershed. They exhibit a passion and willingness to do this very important work on behalf of all inhabitants within the geographic scope of a watershed that covers approximately 30% of the Province of Alberta.

The Watershed Alliance continues to work in areas of education, awareness, providing accurate information, and watershed planning. The board works under a consensus decision making model to ensure that voices from many perspectives - industry, government, nongovernmental agencies, aboriginal communities, and the public at large – can be heard and sectors have the opportunity for participation in the planning process for the watershed. MPWA strives to engage stakeholders to find workable actions, beneficial management practices, and provide advice for policies and guidelines. The prominent areas of work include:

1) Integrated Watershed Management Plan (IWMP) – This complex piece of work, that can look at absolutely everything that happens on the landscape that affects water quality and quantity, was taken out in its draft form to numerous stakeholders for comment and the first MPWA IWMP was accepted by consensus by the Board of Directors in March 2018.

2) Project work: in areas such as Grimshaw Gravels Aquifer, Redwillow, Wapiti River, etc.

3) Continued engagement with councils, stakeholder groups, and residents through meetings, presentations, and forums.

4) Increased education opportunities by offering workshops, school presentations, and attending tradeshows.

5) Participating in broader processes such as Land Use, Alberta WPACs, Water North Coalition, Play-based pilot projects, etc.

6) General Organization and board functioning.

Kudos to the people—Directors and named alternates who put their name forward and participate in the board of directors . Their perseverance to strive towards sound ways forward to protect our water resources.

I appreciate the continued hard work and dedication of the staff. The Staff worked with the board of Directors on a number of projects and initiatives, with the Board framing the goals and the staff putting the pieces together to further project progress.

Mighty Peace Watershed Alliance Financial Highlights 2017/2018

The Mighty Peace Watershed Alliance was granted \$315,612.90, 72% of our total ask from AEP, to move forward with the program as outlined in our strategic plan. Other major funds received and allotted for projects including sponsorship totals \$252,000. With funds received and an estimated \$185,976 In-Kind support from organizations in the Peace, the MPWA continues to forge ahead.

AEP funds are to be used to support operating costs such as salaries, office capital and supplies. They are traditionally doled out, 80% following the awarding of the grant and 20% following the interim report. These funds are to be completely spent by March 31 of each year. Unfortunately by the time the funds become available, it is well into the fiscal year, meaning there is less than a year to complete the project. In 2017/18, the MPWA had 10 months to complete, 12 month projects. Another issue the MPWA faces is that our staff must go on reduced hours or even close the doors beginning April 1 because of the timing of funding application, confirmation, and distribution. This makes it extremely difficult to retain staff, although the MPWA has been lucky with having understanding staff committed to the organization.

As the youngest of eleven Watershed Planning and Advisory Councils in Alberta, and despite our financial challenges, several milestones have been completed. The first State of the Watershed report was supported by the community and completed in 2015 and the Integrated Management Plan was completed in March 2018. These important documents can be accessed on the website (www.mightypeacewatershedalliance.org).

In addition, a number of projects in the watershed are in the process of completion or have been completed. Projects include the Heart River Watershed Restoration Project, the Redwillow Watershed Restoration Project, the Wapiti River Management Plan, the Grimshaw Gravels Aquifer Source Water Protection Plan, Streambank Stabilization and Extension project, and the Improved livestock Crossing Project.

The stellar reputation of the MPWA for its ability to spearhead projects and multi-stakeholder planning is growing. Its work is considered imperative to address land use practices of industry, recreation, aboriginal, government and the public, through science, education, communication and policy. The MPWA is moving ahead with its planned activities of 2018, as we wait for news as to the state of our grant funding request. We are excited and honoured to be hosts for the AB WPAC Summit in June, 2018. All the WPACs are invited to visit us in the largest watershed in Alberta and experience our very long summer days.

We thank AEP as our primary partner and supporter; municipal, industry and not-for-profit partners for their financial and in-kind support. I would also like to thank my fellow Directors for their hard work and support. We have a big job to accomplish and without the respect, efforts and humour of the Board, we would not have been able to complete what we have.

Technical Committee Report

Scope of the Technical Committee

The Technical Committee (TC) has been appointed by the Board of Directors of the Mighty Peace Watershed Alliance as a standing committee. Their role is to assist and advise the Board of Directors on technical, scientific and project matters. The technical committee reports directly to the Board of Directors on a regular basis.

The TC was actively supported by the Watershed Coordinator and Executive Director of the Mighty Peace Watershed Alliance.

Tasks Completed in 2017/2018

Partnering with the Grimshaw Gravels Aquifer Management Association and AEP, a Source Water Protection Plan for the Grimshaw Gravels Aquifer has been initiated. Hazard identification and risk assessment are well underway and completion of the plan is expected in 2018-2019.

Improved Livestock Crossing and Streambank Stabilization and Extension are 2 projects taken on by the same project team using Watershed Resiliency and Restoration Program funding. Agroforestry Woodlot Extension Society, Alberta Conservation Association, Cows and Fish and County of Grande Prairie are working with us to improve flood and drought resiliency and water quality. Making better crossings and restoring eroding streams are the on-the-ground work.



The Redwillow Watershed Restoration Project has finalized their Restoration Plan and is awaiting appropriate water conditions to work on fish passage improvement. This project involves many partners.



Alberta Parks and Environment is looking to complete engagement on the final report submitted by the Wapiti River Water Management Plan Steering Committee to support the creation of Water Management Plan.

The TC has been providing input on a range of watershed issues including the Strategic Environmental Assessment of Wood Buffalo National Park, Area Based Regulation Panel, Transboundary Biological Indicators Workshop and updates to the Pulp and Paper Effluent Regulations.

Integrated Watershed Management Plan (IWMP)

The IWMP is complete! Thanks to all who contributed! The IWMP Steering Committee has guided the IWMP process and now they have been appointed by the Board to track and evaluate implementation.

Projects for 2018/2019

New projects will align with the recommendations of the IWMP as we work towards implementation. For the coming year, we anticipate starting work on hydraulic modelling of the Peace River in the Lower Peace and a Wapiti Watershed Source Water Protection Plan. Other potential projects are currently being scoped and the TC

continues to seek, rely on and collaborate with a range of partners.


In the spring of 2017 we were able to release a new children's activity book, the book will be distributed at tradeshows and to school and other programs throughout our watershed.

Education & Outreach Report

Within the past year the Mighty Peace Watershed Alliance has had amazing opportunities to go out and meet with the public across the watershed.

MPWA had the chance to go to local schools within the Peace Watershed to educate the students on water quality and conservation. We also were able to partner with other events throughout the watershed (Beaverlodge Spring Riparian Tour, Hines Creek FINs Release and a two day Riparian Management Course for Land owners).

Mighty Peace Watershed Alliance participated in a number of tradeshows (Grande Prairie Fall Home and Leisure, Clear Hills Country, Peace Country Classic, ATCO Staff Tradeshow and Grande Prairie Earth Day) where we had the opportunity to hand out education resources and engage with the public so they could learn more about their local watershed and projects.

At the tradeshows we were able to provide education about the current projects such as our Integrated Watershed Management Plan.

MPWA also hosted a public forum this year on Watershed Stewardship (How to form or enhance a watershed stewardship group) with guest speakers from the Land Stewardship Centre and Alberta Lake Management Society. 12 people attended.

Implementing a recommendation from our Integrated Watershed Management Plan, the Mighty Peace Watershed Alliance created a Wetland Education Committee. The committee has members from NAIT Boreal Research institute as well as Wetland Specialists from AEP. The Committee will be hosting Wetland Education Workshops for residents and municipalities within the watershed in the 2018 -2019 year.

For the upcoming 2018-2019 fiscal year the Mighty Peace Watershed Alliance is looking forward to engaging the residents of the Peace Watershed and continuing to create more education opportunities for the public.
