

## 1.6. Expectations & role of Board Members – R. Clarke-Gauthier

a. Intro: The designated Watershed Planning and Advisory Council under Water for Life Strategy. Goals: Safe secure drinking water, Healthy aquatic ecosystems, Reliable quality water supplies for a sustainable economy. The Peace River Watershed, the area of land draining into the Peace River, is approximately 30% of the province of Alberta





## b. Vision, Mission, Goals

**Vision:** The Peace is a healthy, sustainable watershed that supports our social, environmental and economic objectives.

**Mission:** To promote watershed excellence, the Mighty Peace Watershed Alliance will monitor cumulative effects from land use practices, industry and other activities in the watershed and work to address issues through science, education, communication, policy and by supporting watershed stewardship.

- c. **Who are we:** The Mighty Peace Watershed Alliance is a group of active stakeholders and communities use consensus decision-making, adaptive management, and innovation to understand and promote living within the watershed.
  - Non-government Organizations: Conservation/Environmental, Watershed Stewardship Groups, Research/Education, Recreation/Tourism/Fisheries, 2 - Public Member at Large
  - Industry: Agriculture, Forestry, Oil and Gas, Utilities, Mining
  - Aboriginal Communities: Metis Nation of Alberta, Metis Settlements General Council, Lower Watershed First Nations, Middle Watershed First Nations, Upper Watershed First nations
  - **Governments:** Provincial, Federal Transboundary, Small Urban Municipalities, Rural Municipalities, Large Urban Municipality

Note: The Board went through an exercise to confirm alignment of the MPWA Strategic Plan goals and the IWMP issues of Concern. The projects and education initiatives are planned to address these concerns and work towards implementation of the integrated Watershed Management Plan.

## f. Funding:

- As the GOA designated WPAC (Watershed Planning and Advisory Council) for the Peace and Slave River Watersheds, we can apply for a AEP grant under the Water for Life Strategy to cover core operations – staff, office, organization and program expenses.
- Dec 4, 2019 received agreement for \$230,000 per year for 4 years (starting April 1, 2019). Typically have received \$300,000-320,000 of a much larger ask.
- Project funding WRRP, ECCC, AT, and Partners (in-kind and \$).
- Other funding a few Municipalities & other stakeholders Must meet the MPWA Objectives to be accepted.

#### i. **Summary**:

- The work of the MPWA is beneficial to Albertans.
- Managing & Protecting our water resources with regards to Water Quality and Quantity is essential for all who live, work and play in the Peace Watershed.

## **Discussions:**

Mr. A. Siad-Omar would like to consider changes to the committee structure by combining some of them and including governance committee.

Mr. B. Lieverse wondered if we worked with the BC side of the Peace River – Ms. R. Clarke-Gauthier indicated that we do discuss ideas and try to keep an eye on the big work or issues in that area, but we have no authority outside the bounds of Alberta. Also, regarding BC hydro, as we are not government agency we have little way to discuss with them. AEP has loose transboundary agreements and specific ways that BC needs to be approached. However, we have established some lines of communication. Bob talked about the BC water group. We also maintain lines of communication with the Mackenzie River Basin Board.

Mr. E. Jorgensen commented that BC hydro does work with communities on the AB side and is aware of their effects on the Ab side
