# 1.1. Call Meeting to Order

- Quorum was present

#### 1.2. Introductions and Director Roundtable (include Sector Info important to MPWA)

- J. Henry Erosion and watershed issues, hoping to extend out workshops. Looking to collaborate with others, the City of GP has reached out regarding some collaborative extension programs for Bear River and the fish kill.
- E. Jorgensen No longer on County Council. Interested in the Floating wetland work that had been talked about by Mackenzie applied research and AIA.
- A. Rowney that Aquatera submitted their WRWMP Implementation Plan to AEP as well as a request to have the Junior Water Act License amended to reflect the Water Conservation Objective recommended within the WRWMP.
- J. Hetu AEP is releasing a new watercourse crossing manual -Crossing planning and audit by AEP
- B. Lieverse BRAGRS is hoping to get fish back into the river by next spring
- B. Devaleriola working on a terms-of-reference between Peace River, Northern Sunrise County, and MPWA for Pat's Creek
- R. Keillor Discovered a wonderful trail from Hines Creek to the Peace River, good walk through the watershed. Thank goodness for Beavers, they saved his area from drought
- D. Walty Has been working with the parties around the Pat's Creek TOR. Will be speaking with the Peace River Engineer and Mayor of Peace River. Working with Bonnie from AEP to sort out Source Water maps Bonnie has been doing tremendous work on this project.
- J. Webb Received funding through the Wood Buffalo Action Plan grant to obtain equipment etc for fisheries and water monitor in lower Peace. Noted the ongoing concern that the loss of wetlands is impacting Bison through loss of habitat.
- A. Siad-Omar starting a review of the Implementation Plan for WRWMP and that will include amendment of the junior license
- V. Lymburner There were water restrictions in place this summer, unfortunately they found out people used more water in a reduced water time.
- E. Garrow Thankful for beavers and holding ponds.
- M. Gairdner After the Municipal Election, Councillor Bressey has moved to different portfolio and has resigned from MPWA. The City has submitted Councillor Thiessen's nomination. They are working to better understand the Fish kills (due largely to bacteria) in Bear Creek, working with County & AEP on this. Also, Bear Creek has very low flow, discussions around mitigating flooding with Sexsmith, Beaverlodge, and Wembley. Monitoring is continuing.

- Suggestion from Vern that perhaps consider actual cost analysis for same job if AEP was doing this work.

#### 2.4. Technical Committee Update - Project Update and Possible New Initiatives -- Mr. A. Norris

- Source Water Protection Plans (SWPP)
  - Reviewed source water protection planning process
  - Working to develop source water maps for every community in the watershed
  - Grimshaw Gravels Aquifer SWPP implementation is focussed on developing a water budget, initiating community-based aquifer monitoring and ongoing outreach around BMPs and aquifers
  - Wapiti Watershed SWPP implementation is engaging decision-makers and initiating cumulative effects monitoring
- Restoration projects focus on maintain and restoring function to maintain to maintain multiple uses on the landscape
  - Improved Livestock Crossing has installed its final crossing (fifth one) and final reporting is being completed
  - Wapiti Watershed Bank Stabilization is continuing to use planting, livestaking and bioengineering to stabilize banks and protect property on the Beaverlodge River and on the Bear River a floodplain is being created for a river avulsion to reduce erosion and protect downstream property
- Smoky Headwaters Initiative is seeking to reducing sediment entering species at risk habitat and provide shading to maintain cooler waters
  - Engagement on Facebook has been very good ~8000
  - fRI Research was engaged to model sediment delivery and riparian shading for this;
     field verification is complete
  - next steps are to develop workplans for this high sediment loading areas, engage schools, and continue water quality monitoring
- Monitoring is undertaken to understand the watershed and provide feedback on the effectiveness of the IWMP
  - LakeKeepers engages volunteers to monitor lakes both winter and summer
  - o Assisted in groundwater monitoring at Evergreen Wetland Centre
- Continue to monitor induced meandering at the Powell property
- Upcoming potential projects include
  - A watershed restoration project in the Bear/Mikkwa watershed
  - Supporting the County of Grande Prairie Agricultural Services Board in their Watershed Restoration and Resiliency Program application
  - Exploring floating wetlands and finding a location to install one

A. Norris: Timeline for BC /AB bilateral to be completed

Carmen de la Chevrotière: Hoping to get out to do engagement in 2022, working with BC and its open to the public

B. Cameron: There have been problems with MPWA directly communicating with the BC gov in the BC peace area (regarding the Wapiti River), however we have had our hands tapped from higher ups in the BC gov for doing this. Are there safety concerns with the Site C construction and slumping issues? How is compliance for emergency management?

Carmen de la Chevrotière: Our job is to help you communicate with the right personnel in the BC govt

D. Walty: It would be good for BC Hydro to present to us about the monitoring they are doing, and how they are working with AB. What are the downstream environmental issues such as water quality, hydrology and fisheries? Carmen de la Chevrotière: I would start with the regulators and go from there

E. Jorgenson: We (Mackenzie County area) had a flood in 2018 and 2020. BC Hydro presented to Council and they used the term Scouring Velocity. I would like AEP to think about when we change the water speed. Sediment is being held and making new islands, I worry about new floods.

D. Walty: How do we get detailed monitoring on this issue?

Carmen de la Chevrotière: I would bring it up with the Mackenzie Basin Board. Who and where to contact? I will bring it to the Board for the MPWA, who to contact and how to proceed.

V. Lymburner: Why does the MPWA not have a seat the transboundary team?

A. Siad-Omar: I am not sure, will check into that.

## 3.1. Office Rent

- MPWA received a notice in late August that AEP would no longer support a no-cost lease agreement as there has been a policy change within the GOA that all user groups that did not fit into the Tier 1 category (essential services to core GOA work) would be charged rent.
- MPWA is asked to pay a cost recovery amount plus 10%.
- Executive sent a letter to the Minister, Deputy Minister and Senior managers that outlined the work the MPWA does and how it aligns with the AEP Mandates. While MPWA was acknowledged for its good work the policy still stands.
- The amount will be \$8005.56 per annum payable as soon as the documents can be drawn up with Alberta Infrastructure.
- Discussion of options, requirements of office, other WPAC situations, etc.
- Discussion about how inappropriate it is that the GOA is asking for the change in the middle of our budget year.





  - BC: will provide updated emergency flows after Site C completed
  - Affected communities not likely to change




