  - 6 prioritized restoration activites are to be selected
    - Adam reviewed project goals and the issue of bank instability as a key cause as identified by Fish and Wildlife
    - Potential Sites Rick Dedick lacks water when dry; riparian area deteriorated; possible Whole Farm Water Management planning site
    - G & D Skwarik possible expansion on streams off of existing site on SE13-81-20-W5.
    - Other Whole Farm Water Management planning sites of proposed from PCBFA.
    - Sebastien mentioned that NSC is now the Wetland Conservation agent/authority; Hogbins brothers another potential good site(s); cattle operators; have a good wetland.
    - Benjamin Creek Green Zone (grazing lease) has weed issues and is proposed for control; some F & W work on site in the past.
    - Culverts (functionality) with fish passage concerns to be identified and addressed. The last one on Benjamin Creek has been renovated with a cement culvert; video/maps show 15% (streambank one-side) of watercourse with over cropping riparian area concerns.

- Need to ID and map all significant riparian sites.
- The old weir is of low priority and/or concern it actually allows fish passage.
