#### 1.4 Director Round Tables – Stakeholders & Concerns

- Ms. E. Manzer indicated that the Town of Peace Rivers bridge is currently under construction; with respect to small urbans, they are spending quite a bit of time, from now until legislation is passed on cannabis, they are waiting to see how things will move forward from an agriculture perspective;
- Mr. D. Walty met with Northern Sunrise County's Reeve and Councillors to promote the MPWA and discuss potential funding for the MPWA. The NSC has done a lot of local watershed work over the past several years and Mr. D. Walty thinks that they should share their work with other

councils (Note: Ms. S. Gerbig also added to the water quality monitoring that the NSC has done over the past thirteen years which is now showing an increased water quality trend); Mr. D. Walty also worked with AEP's GIS Department to prepare maps for the Grimshaw Aquifer, more specifically for up to date water well mapping and had the GIS department look at mapping of riparian areas to give a report card on where riparian areas are failing;

- Mr. D. Benson Has been involved with the Canada Agriculture Partnership Program Committee;
- Ms. S. Gerbig SARDA has been busy, especially with the relaunching of their new website at the
  end of December it is now much faster and mobile friendly She asks that the board take time
  to have a look at the new website and provide feedback; Environmental Farm Plans (EFO) are to
  be renewed every 10 years and therefore she currently has 13 or so that she has to review;
- Mr. T. Saunders persuaded county to enhance shelter belt program by approving that they could be a part of the program. Article was in Ms. S. Gerbig's SARDA magazine.
- Mr. I. Daisley His team, is currently developing an initiative regarding wetland classifications stemming from the Wetland Policy; currently use government base layer, but will use more accurate mapping to assist with preplanning of wetland areas;
- Mr. R. Keillor Involved with summit meetings and planning meetings for the Grimshaw aquifers source water protection plan;
- Mr. J. Webb Attended environmental flow and hydrology workshop looking at the WBNP Strategic Assessment Process on the 10<sup>th</sup> and 11<sup>th</sup> of April; Mr. J. Webb has the package from that workshop, which he will provide to Adam for circulation among the board; Mr. J. Webb will be attending another workshop on May 2/3 in Fort Smith and the intent of the workshop will be consultation/development of the Action Plan that will stem from the WBNP Strategic Assessment Report; In the Wabasca wetlands area (25 townships identified) there is another endangered species (wood bison) and an agency is undertaking a threat assessment with the means to protect the herd and its habitat Environment Canada modeling has indicated that this specific area is that of a wetland and therefore through the assessment, they will be taking a historic approach (this is work that will proceed as the governments go into this discussion about responding to the regional strategic assessment of WB they need to respond to the need for an assessment of hydrology and what changes to flow may be required to restore the flows within the WBNP);
- Mr. C. Thiessen The City of GP's 4 year strategic plan has an three part environmental component – currently awaiting the final draft – should be approved in two to three weeks;

# Guest Speaker: Bin Xu, NAIT Boreal Research Institute, Peatland Restoration (Applied Peatland Research in the Peace River Oil Sands Region)

Mr. Bin Xu's presentation is on the Directors area of the website. The presentation covered:

 Peatland restoration overview – definition of peatlands, their distribution, challenges with restoration and then Mr. Bin Xu reviewed several case studies. In this review initiation, succession, functions and challenges were discussed.

#### 2.3 Financial Report

### a) Expenditure Update

- Ms. R. Clarke-Gauthier reviewed the Expenditure Report up to March 31, 2018;
- Requested an update from AEP regarding when the MPWA can expect funds from the Grant Application that was submitted on February 20<sup>th</sup>; response was that the MPWA should hear back by the end of April and the funds shall be less than what was received last year (note: MPWA had requested \$394,250 to ensure organization and office function as well as providing leadership in partner collaboration, engagement, monitoring, implementation of management tools and educations as indicated in IWMP);
- Remaining funds will be running out shortly, once wages for April are processed;
- At this point there looks like approximately \$13,000 of carryover from the 2017/2018 year. This money will pay for year-end review and AGM.

#### 2.4 Education & Stewardship Committee – Ms. M. Graham/Ms. S. Gerbig

- A number of projects on the go. Still have some challenges that the committee is undertaking.
  One being, the meeting with councils to promote the MPWA Urban Councils are a bit more
  difficult and the committee is therefore seeking invitations to go to these councils to share on
  who and what the MPWA as well as seek funding;
- The Bingo Night is proving to be an issue and therefore the Committee is looking to seek other funding events that would be cost effective and rewarding and that aligns with what we do (i.e. is their potential through river boat races, rubber duck races; etc.);
- MPWA took part in Tradeshow booths at the Peace Country Classic in Grande Prairie (March 8-10), and the Clear Hills County in Hines Creek April 14, and the MPWA is registered for a booth at the Peace River Chamber April 20-21.
- Ms. E. Garrow thinks that the Canadian Road Builders Association should be contacted for potential funding sources and ask that they be involved in Watershed Management;
- Walk Through the Forest, Grande Prairie May 7-9. Ms. M. Graham will be helping with the Wetland Education Booth;
- Riparian Spring Tour in Beaverlodge area May 10;
- Children Activity Booklets have been printed;

## 2.5 Technical Committee Update – Mr. A. Norris

#### **Project Update:**

• **Grimshaw Gravels Aquifer SWPP** – going very well; first workshop happened end of Feb; now working on mitigative strategies and are on schedule to have a plan together by end of June and then conduct public engagement in autumn with finalization of plan to occur by December;

• RWRP – With the delays once again in this project, EDF and Alberta Transportation have given approval to carry over funds until the next fiscal year. Mr. A. Norris presented a talk on "When the barriers to fish passage are social" at the Alberta Society of Professional Biologists Conference on March 13<sup>th</sup>, which provided an interesting review of the RWRP journey (No personal or organizational details were shared). Still awaiting word on final appeals; Adam to add wording on letter that was submitted to the MPWA regarding a request for an additional sitdown meeting.

Action Item: 4/17/2018-1: Mr. A. Norris to update response letter to BRAGRS with wording provided by Board

- WRRP The Improved Livestock Crossing Project First crossing is complete and are waiting spring for livestock to be moved across the structure. Another 2 – 3 sites will be done this year as well as a factsheet.
- The Streambank Stabilization and Extension Project Planning for a stream restoration workshop (September 24<sup>th</sup> – 29<sup>th</sup>) is moving along well Project Team has engaged company out of Grande Prairie to put together video.
- WMNP Strategic Assessment Report The Technical Committee responded on behalf of the Board and focussed on the need for action moving forward. Letter is on website in area.
- Wabasca Wetlands EMSD took over the lead of this project, and they were to host of First
  Nations Knowledge Forum in March (hasn't taken place yet). EMSD is also trying to secure funds
  for an Ethical Space for Wetland Monitoring Discussions but at a present no funds have been
  confirmed.
- Peace River Hydraulic Modelling scoping for this project has been completed. Beyond Lower Peace residents, WBNP is interested in this project. We are trying to secure funds as everything else is in place.
- Wapiti Watershed Source Water Protection Plan Initial meeting with project team partners planned occur in June; and then move forth from there. Starting with a smaller group and then will engage a much larger group at particular points in the process.

  - Source Water Protection;
  - Pesticides, Contaminants;
  - How contractors apply water management practices;
  - Regulated vs. Natural Flows and apply mitigated flows to get back to natural flows;
- How can my experience help others in the watershed make good decisions?
  - Pass the information on to others (Educate THEM);
  - Working with Ag producers on chemicals and water supplies & potential impacts to the Watershed;
  - Learning how FN's want to be engaged and involved;
  - Initiate conversations and get involved within organizations;
  - Bringing issues to the forefront and increasing awareness;
  - Recognize processes;
  - Sustaining efforts over time;
- How do we identify actions that are not limited to what should MPWA do? Rather what can I do to move it forward?
  - Interactions with others;
  - Always bring up the topic when having conversations;
  - Have companies support wetland inventory;
  - Engage people in a positive way Participate and Influence;
  - Getting people involved through day to day conversations;
  - Actively attempting to lobby;
  - Listening to others so that you know where they are and what their concerns may be;
  - Demonstrate and promote rather than telling others what they should;
  - Understand what is going on in your community;
  - If changes are coming, understand the drivers of the change.
