#### 1. Administration

#### 1.5. Expectations and roles of Board Members

- R. Clarke-Gauthier provided an overview of expectations and roles of Board Members and noted the following:
  - Membership established with initiators group 4 general sectors with 5 seats under each sector; mining not filled and none of the first nations seats are filled as of currently;
  - Expectation that board members will attend all or most of the board meetings pre covid in person, since covid, it's a blend of virtual and in-person;
  - If a board member misses 3 consecutive meetings without noting that they can attend – then the board can make the decision to remove that member from the board – has not happened to date – please just always provide a response as to whether or not meetings will be attended;

- Expectation is that an alternate attend at least one (1) meeting a year;
   ensure you are sharing and staying in communication with your alternate in
   the event they are required to attend on your behalf;
- If both are in attendance, the director and alternate must speak as the same voice when making decisions/voting;
- Reviewed MPWA boundaries and showed map to those in attendance;
- Important role is to bring information to the Board and take and share information with your sector;

Note: Chair Thiessen arrived and resumed the Chair.

- 1.6. Round Table All Directors provide updates and information from their sector regarding issues/concerns/ideas around watershed management. (Also, think about what you can bring to the table/org? Priority for You/Your sector? Water & Watershed Info?)
  - C. Thiessen Large Urban Representative Wildfire Season; Still engaging conversation with a couple of groups surrounding the Bear Creek dam about seeing if it can be returned to its natural state and what restoration may look like estimating a \$40-50M project.
  - S. Cairns Ag Rep Noted that a lot of individuals are concerned about Ag water usage and their permits with dugouts and withdrawals; has been looking at water alternatives for livestock.
  - D. Walty Interesting that there were drought concerns in March and April then it rained and rained in May and June; completed a cumulative effects web page for Sturgeon Lake and this is a map that also looks at the amount of human disturbance in the watershed for Sturgeon Lake and maps out the wetlands (types and %);
    - [Abdi HLFN were interested in generating a similar plan have they been engaged?
       D. Walty Not that he is aware of. A. Norris there has been a member of HLFN that has been in contact with Sturgeon Lake]
  - B. Thuong Le Associate Researcher at the Boreal Centre Wetland Team here as an observer as Bin Xu could not attend today. MPWA and the Center have worked together in the past and hope to continue. The Current focus on wetland reclamation methods and validation.
  - W. Patton The new Metis Nation of Alberta name is Otipemisiwak and the new district that she represents is 14. Otherwise as a new board member just taking it all in.
  - B. Lieverse was with the Beaverlodge Artic Grayling Society, which has decided to disband, because it was decided that the Beaverlodge River is not a suitable place to translocate Arctic Grayling to.
  - A. DeWit it was a relief with the amount of rain the area has received; found an interesting
    article about inter-basin water transfers between Canada and the US there is a database
    that has been maintained around that.
  - B. Segal attended session where they discussed landslide in the States that has resulted in disruption in the Milk River's water source – will take time to fix – those communities will have to look at how to deal with that; thought this correlated with Site C and its potential impacts on other communities.
    - R. Keillor- was there any discussion that water allocations would stay the same; she
      indicated that it was not part of the discussion as discussion was focused on
      emergency preparedness.
  - E. Manzer water act licenses have been discussions in their neck of the woods and there were

concerns with the level in the river and potential impacts to intake – water was so low that they could see the intake and what would that mean in the winter if water remained low; reviewed their bylaw (4 underground reservoirs – if levels are too low then certain water restrictions kick in); there have been some conversations regarding Site C (water will have been used 3 times to make electricity prior to that water reaching their town) – are being told that the water levels at their town should not be impacted too much due to Site C; Government of Alberta asked municipalities to come up with drought plans; there is a new industrial project going in on the Wapiti River.

- R. Clarke-Gauthier some communities like Spirit River and to the west are concerned about lack of water – discussions around other alternatives – i.e. Peace River.
- T. Tosh Alternate with Forestry no updates.
- C. Williams RMA is concerned re Site C and Transboundary agreements. Minister Shultz is trying to get an agreement in place looking at all agreements to see what needs to be put in writing; Northern Sunrise County is exploring options for a new raw water intake currently in limbo and awaiting geotechnical reports; Northern Sunrise County's Alternative Land Use Services (ALUS) program is growing and 9000 trees were planted within the county in assistance with its residents this year; at the RMA as if wastewater could be used for dust suppression within 2 weeks that had a mtg with her and they have received authorization from AEP to be able to do that (ww has to be treated and tested to meet the standards which it does);
- W. Thorp new to committee and looking forward to working with the MPWA from a forestry perspective: concern around communications and what the alliance is doing and what it's doing with the forestry industry so this is one of his objectives in being new to the board; climate change and its impact on water and fire is a concern for the forestry industry and what are the cause and effect and how they maintain all the respective needs (i.e. vegetation, water run-off, etc).
- R. Keillor landscape and forest cover is a concern; educating farmers but still work to be done

   thinks we are losing lots of forest cover on private land thinks this is something that could
   be promoted within the MPWA.
- S. Miller nothing new for her sector of Oil and Gas.
- A. Rowney –still working with the Water Act Team on amending the Junior Water Act Licence.
- A. Armstrong provided a background dating back to 1988 including MRBB and MPWA. Also, spoke about his involvement in the WFL strategy. Indicated that Site C will have negative effects; Due to global warming, engineering techniques need to be explored. Paddle Prairie is intending to clear 30,000 acres in the next decade and is looking to move to groundwater. Wants to see action from reports and hold politicians accountable.
- C. Newhook Concerned regarding land practices. West County Watershed Society has a new President, Justin Hetu.
- A. Siad-Omar WPACs fall under a newly minted Division in the Ministry Water & Circular Economy. Working on increasing water availability to communities and would like to see input from smaller communities.

  - Prepared and hosted a Water uses Forum and AGM.

  - New Division in AEPA called Water & Circular Economy WPACs will fit into this new structure under partnerships but will have various avenues and connects throughout the Division. Unsure at this time if this change may mean adjustments to the MRD signed in 2022.
  - We did receive our 2024-2025 grant of \$320, 000.00 from AEPA

# Guest Speaker Presentation: Melody Lepine – Business Lead, Environmental Assessment at the Firelight Group

- Joining in from Ft. McMurray Treaty 8 as member of Mikisew Cree First Nation.
- New to Firelight Group as Business Lead
- Sharing experience and work with MCFN
  - o Not a lot of monitoring to date has gone on within the Athabasca Delta.
  - o have in time initiated their own monitoring program community-based programs within the pasts 10 years gathered water quality monitoring
  - 4-5 years ago, launched one of Canadas first, indigenous led collaborative monitoring groups; funder primarily by Parks Canada
    - Currently building a field station in the Delta where they can do cultural and education programs, house scientists and researchers
  - The facility in Fort Smith has a new research laboratory which was done in partnership with Canada Labs.
    - It's a mobile lab, within the community.
  - Spent a lot of time on Regulatory Work in her time with Mikisew (i.e. related to Site C Dam)
  - Monitoring completed has been towards developing a Base Flow Analysis (incorporates oil sands withdrawals) and identified Indigenous thresholds for use on the Athabasca River.
    - Water had to be shut off during Kearl Oil Sands spill in 2023
  - o Canada needs to action the Wood Buffalo National Park Action Plan

#### 2.4. Grimshaw Gravels Aquifer Summer Steward Report (A. Hustler)

- Lots of activities were attended to promote the GGA Source Water Plan. Also, discussions
  regarding household efficiencies, conservation, water literacy, wetlands, riparian areas, well
  testing.
- Connected with AHS for info on treating hard water and working well info
- Lots of discussion around small nuclear reactors.
- Water monitoring at various locations

- Lake level logger has been deployed in Lac Cardinal

#### **2.7. Technical Committee Updates** – A. Norris

- Planning a workshop for the Source water Protection Webtool being developed as part of the Alberta Water Council Source Water Protection Project Team. We will also be doing a workshop at the Alberta Water and Wastewater Operators Association conference.
- Boreal Wetland Centre we are continuing to sit on the advisory board, to do groundwater monitoring and helping organize the Wetland Innovation Workshop.
- Cumulative Effects of Wildfire on Groundwater grant applications have been submitted and now we are waiting to hear back
- Floating Treatment Wetlands there was a Grade 8 class school trip to launch the rafts and harvest plants; water quality monitoring has happened throughout the summer and we will engage students to harvest and remove the rafts.
- Grimshaw Gravels Aquifer A. Hustler did a great job actioning our Source Water Protection Plan recommendations this past summer
- Lower Peace Freshwater Contaminant Reduction almost wrapped just have one field trip planned to do some livestaking and Knowledge Transfer and Translation this autumn
- Reducing Invasive Species in the Peace-Athabasca Delta this has been challenging as our partner, Little Red River Cree Nation, has dealt with wildfires in the past 2 years; still need to complete control work
- Redwillow Watershed Restoration Plan hydraulic modelling is almost complete for the Redwillow watershed; the water quality monitoring program continues.
- Source Water maps we will present these at the next Water North Coalition meeting and then look to engage individual communities
- Victor Lake Riparian Assessment worked with Mountain Metis Nation Association to complete riparian assessment of Victor Lake and assess some watershed issues. Trained several of their youth on these protocols.

previously. The project is now complete.
