1. Administration

1.1. Call Meeting to Order & Quorum Statement & Introductions

- Meeting called to order at 9:15 AM by Chairman Chris Thiessen.
- Quorum was present.

1.2. Approval of Agenda – Additions or Deletions

1.3. Approval of Minutes

- Meeting Minutes for August 19, 2024 were reviewed.
- A. DeWit proposed and amendment to the August 19, 2024 minutes such that the Round Table comments were amended to say, "water transfers *in* Canada and the US".

1.4. Director Resignation

Wendy Patton has submitted their registration to the Board. The Metis Nation of Alberta –
District 14, seat is now vacant.

The registration was accepted by the board with regret.

1.5. Expectations and roles of Board Members

- Chair, C. Thiessen shared his hope that there will be a full board by the MPWA's AGM next year, in 2025. The MPWA is working on refreshing the SOW and the IWMP. He shared that there will be an increase in learning and participation from board members as MPWA reviews and revises these documents. He reiterated that the next 2 years will be busy and will involve lots of education and learning for the board.
- R. Clarke-Gauthier reiterated to please answer emails in a timely manner to ensure board member's voices are heard. Amy Charles resigned from the E&O position at the end of August. Advertising for new staff were posted. Interviews were held, Adanna Hustler took on the position in mid October. Please email Rhonda if you are unsure of which staff member to contact.
- R. Clarke-Gauthier shared the organization chart, including all board seats and staff. Board elects, Chair, secretary, treasurer. The Board's only staff member is Rhonda. There are the following committees nominations committee, technical committee, education and stewardship committee, IWMP steering committee, executive/finance committee. The education and stewardship committee is currently non functioning but will be in 2025 after the Terms of Reference are reviewed.
- B. Segal asked where the descriptions for each committee can be found. Rhonda clarified that they can be found on the Directors site.

GUEST SPEAKER: Marsha Trites-Russel – Wetlands Specialist, AEPA – 9:32 AM

- Reviewed the AB wetland policy, wetland classification in AB. Mitigation techniques including avoid, minimize and replace. Wetland replacement can be fulfilled by purchasing credits, make a payment to the in-lieu fee program, undertake permitted responsible replacement. A code of practice was introduced in 2020 as part of the red tape reduction program.
- Wetland Replacement Program was introduced in 2020 which aims to provide resources for collaborative agreements.
- Program elements MOU, identify potential replacement sites, proposal, contract, approvals + construction, monitoring
- Fen restoration near Wabasca, several projects in County of GP, MD of Greenview near Victor Lake. Inventory pilot project with Ducks Unlimited and ABMI to update wetland inventory.
- Questions for Marsha:
 - o R. Keillor asked how readily available the LiDAR to the public.
 - O B. Segal asked if the province is updating their wetland inventory. Marsha clarified that the pilot project is all that is planned so far.
 - B. Segal asked how wildfires have affected the wetlands in AB. Marsha clarified that
 the smoke made the inventory difficult. Areas affected by fires may change
 classifications due to changes in vegetation in burnt areas.
 - E. Manzer asked how much money may be allocated to projects and where funding is being procured.
 - C. Theissen asked how the fire break south of GP would be implicated in wetland replacement. Marsha said that it was her belief that the replacements have been done.
 - A. Norris asked where the 5 million dollars influx has come from. Marsha clarified that that money is from wetland replacement credits.
 - R. Keillor asked how immediate response vs. ditch plugging. Marsha said that most projects are ditch plugging and most are functional within 5 years.

 of Finance, Honourable Mr. Nate Horner, where the topics of 'how to monetize water
 resources such as nuclear, Site C and lithium mining' were discussed.

- Adam, Rhonda and Chris attended an AEP/Water Partners meeting in Edmonton Nov 20th, but due to a small meeting space, only 3 people from each organization were invited to attend. They discussed the 7 themes of the Water availability Engagement and an indepth exploring of inter-basin water transfers, .
- Met with the IWMP SC last week.

2.5. Technical Committee Updates - A. Norris & A. Graham

A. Graham

- Floating Treatment Wetlands
 - Installation took place in June 2024
 - Raft Removal October 23, 2024 (tip for next year get them out before the ice forms)
 - Still working on data compilation and assessment
- Wetlands & Watersheds: Making the Connection presentation at the Wetland Innovation Workshop on Sept 25th, 2024
- Beaverlodge Monitoring
 - o Final Sampling November 5th and 6th for 2024
 - o Madison K. with AEP joined Ashley at the last monitoring event
 - Consisted of nine (9) monitoring sites no data as of yet, but Ashley working on analyzing it - Future consideration to do less sites as nine (9) is a lot
- Lake Keepers
 - The lakes currently in mind are Swan, Sturgeon and Snipe
 - One volunteer confirmed for the Winter 2025 Sampling event
 - ALMS 2025 Winter Sampling Training Webinar December 10, 2024
- CABIN 2025/2026
 - Currently applying for funding through Forest Resource Improvement Association of Alberta FRIAA), Forest Resource Improvement Program (FRIP)
 - Canadian Aquatic Biomonitoring Network (CABIN) led by ECCC and is a collaborative initiative that provides standardized protocols for monitoring the

- health of the aquatic ecosystems across Canada
- Focuses on assessing ecosystem health through the collection and analysis of benthic macroinvertebrates, with data shared through a web-accessible database.
- Many other WPACs are already participating in this initiative
- Within our watershed we would be looking South of Grande Prairie focus is on less disturbed areas so is site specific; as a whole, this program is currently focused on an 'eastern slope collaborative'
 - Then this protocol could be taken and used for the rest of the Province

A. Norris

- Cumulative effects of wildfire on Groundwater
 - Partner with InnoTech Alberta, where the MPWA contributes field work in the
 Peace currently waiting for funding approval
- Grimshaw Gravel Aquifers SWPP
 - Started accessing potential losses (i.e. evaporative losses) used linear regressions and found that physical parameters (sun, wind, rain) is not the primary determinant of lake level – this provides more evidence for the aquifer being the primary driver of lake level.. Will monitor again in 2025
- Lower Peace Freshwater Contaminant Reduction
 - Project had two (2) sites was about engaging landowners to change practices to reduce their impacts; now complete except for final reporting.
- Peace River Tributaries Project Partners are the Northern Sunrise County, Mackenzie County and landowners; Water Resiliency and Restoration Program (WRRP) Application was submitted for funding;
- Redwillow Watershed Restoration Project spent time finalizing model and now we need to find funding/money in order to run it; exploratory 'what if' tool
- Reducing Invasive Species in the Peace-Athabasca Delta
 - Worked with Little Red over concerns regarding thistle getting into the Delta
 - Parks Canada has interest in the report and suspect thistle was brought in by bales (i.e. feed) into the Province
 - Didn't find thistle on the Wabasca or the Peace River Mainstem
 - Project is complete except for final reporting and some final ongoing promotional work.
- Resiliency in the Wapiti Watershed
 - Just received funding through a grant two (2) sites with one (1) along the Redwillow River and the other near Saskatoon Mountain
- Source Water Maps worked with Dave Walty on the maps re: watershed characterization

Lunch Break

GUEST SPEAKER: Bradley Peter, Executive Director, Alberta Lake Management Society (ALMS) (12:42 PM)

- ALMS has been around since 1991 and the ALMS is focused on Lakes
- Main program is LakeWatch in which the ALMS staff works alongside the public to gather
 monitoring data community-based monitoring of Alberta's Lakes for nearly 30 years monitor
 5 lakes/year, every 4 years ALMS does the monitoring alongside Conservation officers data
 is uploaded into the Gov't database and Datastream platforms; when doing this monitoring they

- are looking at trends and do publish this trended data annually monitoring shows decreasing and increasing trends See Annual Trend Summary at www.alms.ca/reports
- The Lake Keepers Program is a traditional citizen science program where volunteers are trained and equipped to collect data and is designed to support remote and under-sampled waterbodies. After launching the summer monitoring program, they identified a gap with winter monitoring programs (or lack thereof) so they put out the most significant effort to understand winter lakes in Alberta and trained and equipped citizen scientists and winter anglers to monitor Alberta lakes
- Indigenous Community-Based Monitoring Program Supporting 8 Indigenous communities in the Alberta Oil-Sans Region with year-round lake monitoring is an enhanced monitoring program. This data gets uploaded to an oil sands data portal, so its not accessible for most and the Indigenous communities have closed data sharing agreements in place.
- Involved in collected data for 'Recreational Beach Monitoring' have a contract to perform AHS
 beach monitoring each year enhanced monitoring for rare cyanobacterial toxins including
 anatoxin and cylindrospermopsin. This data goes into a spreadsheet which can be found on the
 government website. All historical data can be referenced in one spreadsheet. This information
 can be used to form public advisories.
- Almost all of the monitoring that ALMS does includes invasive species monitoring. No aquatic
 invasive mussels were detected in 2023 or 2024 they do look annually for them but have yet
 been found in any of the monitoring that they do. Not saying they aren't here they just haven't
 been found in monitoring that has occurred.
- Been working on a satellite project for the last two (2) years with the goal to model lake water quality was a highly collaborative project samples collected during flyover data of Sentinel 2 satellites on cloud-free days sample 20-30 locations each time there is a satellite flyover and use this data/information to convert the data into an image; can take bloom duration, extent and intensity and generate an index that can be used from year-to-year

 - Still need a Director to fill the Industry Representative

Motion: A. DeWit nominated Wayne Thorpe to fill the Industry seat on the IWMP SC as there were no further nominations, W. Thorpe accepted the nomination. Seconder by B. Lieverse.

Update of Committee Work

- Why do a SOW? mandate; baseline that tells us the status of the watershed at one point in time; helps assess if things are good, bad or otherwise; helps identify issues and potential solutions; its proactive and helps us engage the community; and reporting – helps getting information out to groups for planning.
- MPWA to do assessment and reporting and the Gov't to do policy/standards and use the input of the work the MPWA does;
- SOW and IWMP are linked and the main bulk of the work the MPWA does look at triggers, plan, implement, then monitor and report and then transition over to review which is currently where we are sitting in the iterative process (noting that the first iteration was our baseline development)

- 3.1. Water Availability Engagement Review. MPWA Submission. All Individual Board members should do surveys and distribute to as many in your sector as possible to participate. The survey ends January 10 (no extensions). Remember to include messaging around all that is working as well as suggestions.
 - Board members were sent email via R. Clarke-Gauthier, highlighting dates for the Water Availability Engagement – some members were able to attend in person, some virtually
 - R. Clarke-Gauthier encouraged board members to take part in the survey
 - Board indicated that R. Clarke-Gauthier should submit a survey response on behalf of MPWA
 - Water Availability Engagement Survey trying to get an understanding of about what the
 people of Alberta want to share about water survey stems from Ministers mandate
 that she was given back in 2023 when WPACs talked to the Minister, it was noted that
 'First in Time, First in Right' (FITFIR) under the Water Act would not be touched during
 this process
 - Did a round table exercise to discuss tops highlighted in the Water Availability Survey
